1. Introduction, Purpose and Scope of Policy:

1.1 Morley College London is committed to operating in an ethical and principled way. The aim of this policy and procedure is primarily to provide all workers with a means of raising genuine concerns of suspected bribery, breaches of the law (including failure to comply with statutory obligations such as those relating to Safeguarding and Prevent) and other serious wrongdoing.

1.2 The College encourage workers to raise genuine concerns about suspected wrongdoing at the earliest practicable stage. This policy and procedure is intended to provide safeguards to enable members of staff to raise concerns about malpractice in connection with the College.

2. Equality and Diversity Analysis Screening:

2.1 In accordance with the College's Equality and Diversity Policy, the development of this policy complies with the Equality Act 2010 in ensuring due regard to eliminating discrimination, advancing equality of opportunity and fostering good relations.

them. The law allows workers to raise such concerns externally and this policy informs workers how they can do so. However, a failure to raise a concern under this procedure may result in a disclosure losing its protected status under the law.

- 6.2 This policy and procedure seeks to balance the need to allow a culture of openness against the need to protect other workers against vexatious allegations or allegations, which are not well-founded.

7. Policy Statement

- 7.1 The College is committed to the principles of openness and accountability, which underpin the legislation protecting whistleblowers (the Public Interest Disclosure Act 1998).
- 7.2 This policy and procedure reflect the College's dedication to transparency, accountability and the well-being of the College community, as we work together to create an environment where individuals feel empowered to speak up about concerns without fear of reprisal.
- 7.3 This policy and procedure should not be used for complaints relating to a worker's own circumstances. In these instances, the worker should use the Grievance Policy and Procedure for non-Senior Post Holders.

8. Implementation of Policy:

8.1 *Protected Disclosures*

8.1.1 The law protects workers who, out of a sense of public duty, want to reveal suspected wrongdoing or malpractice.

8.1.2 The law allows a worker to raise what it defines as a 'protected disclosure'. In order to be a protected disclosure, a disclosure must relate to a specific subject matter (See Section 8.2 below) and the disclosure must also be made in an appropriate way (See Section 8.3). A 'protected disclosure' must, in the reasonable belief of the worker making it, also be made in the public interest. A protected disclosure must consist of information and not merely be an allegation of suspected malpractice

8.2 *Specific Subject Matter*

8.2.1 This policy and procedure must be used if a worker becomes aware of information which is a protected disclosure under the Public Interest Disclosure Act 1998.

8.3 *Procedure for making a disclosure*

- 8.3.1 Information that a worker reasonably believes tends to show one or more of the situations given in section 8.2 should promptly be disclosed to the Principal, the Chief Finance Officer, the Chief Planning and Data Officer or the Chief People Officer.
- 8.3.2 If the disclosure relates to the Principal, a worker can raise the issue with the Director of Governance. If that is inappropriate (for example, because the disclosure relates to both the Principal and the Director of Governance) the issue may be raised with the Chair of Governors, or (if the disclosure relates to the Chair, Principal and Director of Governance) with the Chair of the Audit Committee.
- 8.3.3 Workers are encouraged to identify themselves when making disclosures. If an anonymous disclosure is made, the College will not be in a position to notify the individual making the disclosure of the outcome of action taken by the College. Anonymity also means that the College will have difficulty in investigating such a concern. The College reserves the right to determine whether to apply this procedure in respect of an anonymous disclosure in the light of the following considerations:
- the seriousness of the issues raised in the disclosure;
 - the credibility of the concern; and
 - how likely it is that the concern can be confirmed from attributable sources
- 8.3.4 For further guidance in relation to this policy and procedure, or concerning the use of the disclosure procedure generally, workers should speak in confidence to the Chief People Officer.

8.4 *Procedure for Investigation of a disclosure*

- 8.4.1 When a worker makes a disclosure, the College will acknowledge its receipt, in writing, within a reasonable time.
- 8.4.1 The College will then determine whether or not it believes that the disclosure is wholly without substance or merit. This determination will be made by the person to whom the disclosure has been made, who may, if appropriate, consult any other governor or senior officer of the College who is not the subject of the disclosure. If the College considers that the disclosure does not have sufficient merit to warrant further action, the worker will be notified in writing of the reasons for the College's decision and advised that no further action will be taken by the College under this policy and procedure. Considerations to be taken into account when making this determination may include the following:
- if the College is satisfied that a worker does not have a reasonable belief that suspected malpractice is occurring; or
 - if the matter is already the subject of legal proceedings or appropriate action by an external body; or
 - if the matter is already subject to another appropriate College procedure.
- 8.4.2 When a worker makes a disclosure that has sufficient substance or merit warranting further action, the College will investigate the disclosure and take appropriate action.

- 8.4.3 If an internal investigation is appropriate, it will be conducted by a manager of the College without any direct association with the individual to whom the disclosure relates, or by an independent governor or an external investigator appointed by the College. In some cases, the College may appoint a team of investigators including individuals with relevant experience of investigations or specialist knowledge of the subject matter.
- 8.4.4 Any recommendations for further action arising out of the investigation will be addressed to the Principal or Chair of the Governing Body, as appropriate in the circumstances. The recipient will take all steps within his or her power to ensure that the recommendations are implemented unless there are good reasons for not doing so.
- 8.4.5 The worker making the disclosure will normally be notified of the outcome of any action taken by the College under this policy and procedure within a reasonable period of time. The need for confidentiality may sometimes, however, prevent the College from giving the worker specific details of the investigation or any disciplinary action taken as a result. Workers should treat any information about an investigation as confidential.
- 8.4.6 If the worker is not satisfied that their concern has been appropriately addressed, they can appeal against the outcome by raising the issue within 5 working days with the Chair of Governors or, if the initial disclosure was made to the Chair of Governors, with the Chair of the Audit Committee. The Chair of Governors or Chair of the Audit Committee will make a final decision on action to be taken and notify the worker making the disclosure.

8.5 *Safeguards for workers making disclosures*

- 8.5.1 A worker making a disclosure under this procedure can expect the matter to be treated confidentially by the College and their name will not be disclosed to anyone implicated in the suspected wrongdoing without their prior approval.
- 8.5.2 The College will take all reasonable steps to ensure that any report of recommendations, or other relevant documentation, produced by the College does not identify the worker making the disclosure without their written consent, unless the College is legally obliged to do so, or needs to do so for the purpose of seeking legal advice.

8.6.2 A worker making a disclosure outside the College may only do so to a prescribed person or body that deals with the type of issue that is the subject of the disclosure. A list of prescribed persons and bodies, showing the types of issue that each is able to address, can be found on the [GOV.UK](https://www.gov.uk) website.
